- If you cancel within 30 days after admission to the programme, a cancellation fee of \in 1.450,= is applicable. After this date the full study fee is due.
- The study fee is €14.500,=, excluding cost for any bridging courses (if applicable). The study fee is for the period September 2025 August 2027. In case a student does not finish the programme within 2 years, an additional fee is due.
