Such a combined trajectory will prepare you for the theoretical part of the Dutch auditor license in approximately two and a half year to three years – depending on the extent to which the bachelor programme already covered the necessary accountancy topics. The special tuition fee for combining the two programmes is €25.500 (excluding the cost of any bridging courses (if applicable)).

- If you cancel your registration within 30 days of admission to the executive Master of Science in International Accountancy programme, a cancellation fee of €1.975 will apply. After this date, the full study fee is payable.
- The study fee for the executive Master of Science in International Accountancy is €19.750, excluding the cost of any bridging courses (if applicable). The study fee is for the period September 2026 - August 2028. If a student does not complete the programme within 2 years, an additional fee will be payable. The additional fee is 25% of the study fee and will be charged every 6 months (September-February & March-August) until the student has successfully completed the Master of Science in International Accountancy programme.
- The special study fee for the combined executive Master of Science in International Accountancy programme and Post-Master in International Accountancy is €25.500, excluding the cost of any bridging courses (if applicable). The study fee is for the period September 2026 - August 2029. If a student does not complete the combined programmes within 3 years, an additional fee is payable. The additional fee is 25% of the study fee for the programme(s) not yet completed; the study fee for the Master of Science in International Accountancy programme is €19.750, the study fee for the Post-Master in International Accountancy is €15.000. This fee will be charged every 6 months (September-February & March-August) until the student has successfully completed the programme(s).
